# GENERAL TERMS AND CONDITIONS

## 1. Definition

In these General Terms and Conditions (hereinafter also referred to as 'Terms and Conditions') the following words shall have the following meanings:

- 'DJMD': Dutch – Japanese Maritime Desk K.K. -
- 'Participant': DJMD's contractual other party
- 'Agreement': the registration form submitted by the participant, confirmed in writing by DJMD, including these Terms and Conditions which shall be deemed to form part of the agreement;
- 'Project': any Fair Participation, Trade Mission, Seminar or Market Survey arranged for by DJMD;
- 'Fair Participation': any participation in trade fairs arranged for by DJMD independently or on commission from third parties;
- 'Trade Mission': any joint trip or visit organized by DJMD;
- 'Seminar': every activity organized by DJMD for the transfer of knowledge, including workshops;
- 'Execution': the execution of Services and / or the Supply of Goods by DJMD;
- 'Contract Sum': the price which DJMD is owed for the participation in the Project based on the Agreement; - 'Personnel': all staff deployed directly or indirectly by DJMD and / or hired by DJMD

## 2. General

2.1 These Terms and Conditions and the Agreement may be amended and added to only if such amendment or addition has been expressly agreed in writing.

2.2 The Agreement shall replace all previous oral and written agreements relating to the subject of the Agreement.

2.3 All of DJMD's offers made shall be without obligation.

2.4 DJMD shall be entitled to hire a subcontractor and / or to transfer (part of) its rights and obligations arising from the Agreement to a third party for the execution of the Agreement.

## 3. Registration, confirmation and cancellation

3.1 Requests for participation in a Project shall be made by submitting a signed copy of the project application form to DJMD.

3.2 Following registration, the applicant shall receive written confirmation of participation.

3.3 DJMD shall be entitled, without stating reasons, to exclude applicants from participation.

3.4 In the event of an insufficient number of participants, DJMD shall be entitled to cancel the Project.

3.5 DJMD shall be entitled to cancel participation at any time if the participant has failed to settle the invoices (in time). Any and all consequences of such cancellation shall be for the account and risk of the participant in question.

3.6 Participants who cancel up to two weeks prior to commencement of the activity shall be obliged to pay 50% of the Contract Sum. Participants who cancel between two and one week before commencement of the activity shall be obliged to pay 75% of the Contract Sum. In all other cases, participants may not cancel the agreement and shall be obliged to pay the full Contract Sum.

3.7 Article 3.6 shall not apply to travel arrangements. Full or partial cancellation by the participant shall never discharge participants from the obligation to pay the travel sum in full.

## 4. Payment

4.1 Payment of the Contract Sum must take place prior to the commencement of the Project.

4.2 Without prejudice to the first paragraph, payment must take place by transfer of the invoiced amount within 14 (fourteen) days following the invoice date into the bank account designated for this purpose by DJMD. Payment shall take place without any settlement, claims, compensation, or deduction made.

4.3 At DJMD's reasonable request, the participant shall provide surety for the full Contract Sum. If the participant fails to meet such request, DJMD shall have the right to suspend or terminate the Agreement in full or in part subject to a written notice to the participant.

4.4 The participant shall inform DJMD in writing of any objection concerning the content of an invoice within 7 days following the date of the invoice. If the participant fails to do so, the invoice shall be deemed to have been accepted by the participant.

4.5 If the Participant fails to meet any of the obligations set out above, they shall owe DJMD interest on the outstanding amount charged at 1.5 % (one and a half percent) per month or part of a month. Moreover, DJMD shall be entitled to suspend the Agreement following written notification, until payment has been received, subject to the stipulations of the Agreement or stipulations of these Terms and Conditions. Any and all extrajudicial and judicial costs shall be for the account of the participant, subject to a minimum of 15% (fifteen percent) of the amount to be collected.

## **5. Liability**

5.1 DJMD guarantees that it shall expend its best effort in executing the Project. A more detailed guarantee with regard to the execution of projects will not be issued and the contractual liability of DJMD shall be restricted to the observance of these guarantee obligations.

5.2 Moreover, DJMD's liability shall be restricted to the Contract Sum at all times.

5.3 The participant shall indemnify DJMD for any and all third-party liability that is the result of, that results from or that is related to the (execution of the) Agreement, unless DJMD is liable vis-à-vis the participant.

5.4 Save for cases of serious fault or negligence, DJMD shall not be liable for any loss, injury or any other damage suffered by the participant following cancellation of the Project or the travel arrangement. In the event of cancellation by DJMD, any down payments shall be refunded, following deduction of any costs made.

## **6. Suspension and termination of the Agreement**

In the event of force majeure, each party, independent of the other party, shall be entitled to terminate the Agreement if the period of force majeure has continued uninterrupted for 6 months. In addition, DJMD shall be entitled to terminate or suspend the execution of the obligations arising from the Agreement in case the Participant fails to meet an obligation arising from these Terms and Conditions, or if DJMD has reason to assume that the Participant is unable to meet those obligations.

## **7. Applicable law and competence**

7.1 Dutch law applies to this Agreement and all obligations arising from this agreement.

7.2 All disputes related to this Agreement shall be solved amicably between the parties involved.

7.3 If the participant is registered in the Netherlands and the amicable settlement is not acceptable to the contract parties, the dispute shall be placed before the competent court in the Netherlands.
